Report of the Superintendent of Schools

To the Honorable School Committee, Board of Selectmen, and Citizens of North Kennebunkport.

Ladies and Gentlemen:

It is with more pleasure than usual that I present this, my fifteenth annual report of schools.

In recent years I have pointed out that each year the school census was increasing; this year is no exception. Moreover, the enrollment is the highest in all the years since North Kennebunk. port has been a town. In 1926 there were only 140 pupils in the Town of No. Kennebunkport between the ages of 5 and 21 years of age. Today, there are 258 pupils of these ages. In 1926 there were only 54 pupils in your schools. Today there are 152. This is an advance of 281 in the school population actually attending your schools. There is evidence that the schools at Burnham, Iron Bridge, and Durell Schools will be unable to house the pupils eligible to enrollment in these schools, if the present conditions prevail. Iron Bridge may have more pupils appearing for enrollment who are temporarily in Parochial School, than could be properly housed.

The conditions appearing at the Burnham School are even more acute. The first four elementary grades at Burnham have enrolled 39 pupils. The grades five to nine in Burnham have enrolled 40 pupils. This is both a capacity teacher load and makes for acute overcrowding. The North Chapel and Irving Schools have a comfortable enrollment and can handle all such pupils as may desire to attend these schools. At the present Town Meeting the citizens of North Kennebunkport should thoroughly discuss what your Superintending School Committee should do in case some of these schools are unable to house the pupils seeking to enroll.

EQUALIZATION FUND

Last year I quoted a letter from Commissioner Bertram E. Packard as indicating that the Equalization Fund could not be considered as a tax reduction measure. It was rather an effort on behalf of the State to afford to the towns making a desperate struggle to have a program of education including minimum essentials to guarantee those essentials.

The first essentials are text-books, supplies, reference books. maps, and globes, those items that advance teaching. Indeed, teachers have to have tools to teach at all. The allocation of the Equalization Fund more and more depends on the school rate which in turn depends on the amount of school money raised at Town Meeting. Now the law limits the ways this fund can be expended, which is precisely as the common school fund itself is expended.

After correspondence with Mr. R. E. Libby, State Agent for Rural Education, it was thought the Equalization Fund might not always be shared by North Kennebunkport, and that in view of the enrollment being so large, that the best policy was to start in and equip each school with modern and up-to-date text books and thereafter keep them up to an acceptable standard. This has been done and, I think, been done with an expected maximum of educational returns.

The state made a considerable survey of your schools this last year. The representative from the State Department was Miss. Yvonne Daigle. She made a survey of each school and evaluated the teaching methods and equipment of each school. In some particulars we have closely followed suggestions growing out of this survey. Miss Daigle gave a high rating to your teachers and their professional ability and in regard to books we have fulfilled the essential requirements.

Mrs. Grace Ham Smith, who was given leave of absence last year for the winter and spring term, returned this fall, and has been doing good work. We welcome Mrs. Smith back and hope her work may be increasingly happy for her as it is satisfactory to us. The entire teaching staff of North Kennebunkport have without exception had the most intellectual and satisfactory approach to the curriculum that has prevailed during my period of service. They have been progressive beyond expectation. They have attended all teachers' meetings, State, and County Meetings, and have returned to their respective schools to impart some of the inspiration and hope they received at these meetings to their respective schools.

The Town of Kennebunk closed the Alewive School last September and transported all their rural scholars to their City Schools. This situation made it obligatory for North Kennebunkport either to pay tuition and transportation for their pupils to Kennebunk for such pupils as live at Days Mills, or furnish transportation to the Irving School. The Board found that it was financially much better to transport these pupils to the Irving School. This was consequently done. The distance that these pupils, three in number, had to travel made it mandatory for them to be transported. Mrs. Margaret Emmons was given a contract by the Superintending School Committee at not more than five dollars per week for this service. This plan has worked out well. The transportation service regulations come under the jurisdiction of the Highway Department. The law provides for insurance of one foot linear space for each pupil, and other rigid requirements which have to be complied with under the State Highway Supervisor. This makes transportation more exacting than formerly.

The State Highway Department inaugurated a safety drive through contacts with the schools. Your schools cooperated to the fullest extent in this safety campaign. We further supplemented this work with much safety material and set up a reading and study curriculum to further this work. Your teachers were much interested in this needed type of instruction and have made good use of the materials offered for this type of work. This year for the first time, study readers built on grade level dealing with science have been offered to your pupils. This is a wonderful new field and is packed with interest for the different grades. I feel this development is significant.

There is another most significant development that has taken shape in the teaching curriculum in your schools. It is an attempt on grade level and within the mental group and interests of each of the first six grades, to teach those fundamental facts that make up the essence of free government. These materials are published in a beautiful set of Democracy readers and will hence forth be used both as Social Science materials and as supplementary readers. It is the first time in American Education that material developed on the first six grade levels has been available in language and suitable illustration for these grades. Your town is the first to attempt the new work in southern Maine. This advantage could not be attempted except for the Equalization Fund.

In conclusion I wish to thank your teachers for the splendid cooperation they have rendered to every school undertaking on which we have ventured. They have done more than has been asked and the standard in your schools has been advanced in many different directions.

The Superintending School Committee has been most helpful and shares with me the pride we feel in the achievements brought to your pupils through the combined effort of you all. It is commonly believed that in some respects the intellectual achievements of your pupils and advantages they have had the past year are comparable with much larger centers. Finally, let me express to you all, that if we, as a free people are to ever attain our manifest destiny, it will be because towns like yours never lose sight of the place education is to play among a free people.

REPORT OF COUNTY NURSE

To the Citizens of the Town of North Kennebunkport, I herewith submit my annual report as public health nurse for the year 1939.

Much time was spent during the past year visiting the homes of children found, during school health inspections, to have defective vision, in making arrangements for eye examinations and in obtaining financial aid for those needing glasses. Most of these cases have been taken care of through the generosity of the Kennebunkport Chapter of the Red Cross. Arrangements were also made for several children to have tonsil and adenoid operations and these were paid for by the Kennebunkport Red Cross. It would seem, where there are so many school children in North Kennebunkport in need of aid in securing corrections, that it might be of great assistance to the nurse to have a town appropriation which she might call upon for some of this corrective work.

Other home visits were made following health inspections because of children found with pediculosis or of absence from school because of illness.

WARRANT

For TOWN Meeting, March 4, 1940

STATE OF MAINE

County of York, ss.

To George A. Merrill, Constable of the Town of North Kennebunkport in said County, GREETINGS:.

In the name of the State of Maine, you are hereby required to notify and warn the inhabitants of said Town of North Kennebunkport, qualified by law to vote in town affairs, to assemble at the Town House, in said town, on the 4th day of March, 1940, at ten o'clock in the forenoon, to act on the following articles, to wit:

Article 1. To choose a moderator to preside at said meeting.

Article 2. To see if the Town will vote to dispense with the check list at this meeting.

Article 3. To choose all necessary Town officers for the ensuing year.

Article 4. To see what sum of money the Town will vote to raise for the support of common schools.

Article 5. To see what sum of money the Town will vote to raise for high school tuition.

Article 6. To see what sum of money the Town will vote to raise for repairs and insurance on school buildings.

Article 7. To see what sum of money the Town will vote to raise for free text books.

Article 8. To see what sum of money the Town will vote to raise for school supplies.

Article 9. To see what sum of money the Town will vote to raise for the salary of the Superintendent of schools.

Article 10. To see what sum of money the Town will vote to raise for the repair of roads and bridges.

Article 11. To see what sum of money shall be paid to the road commissioners per day for their services, and fix the price per hour to be paid for labor on highways.

Article 12. To see if the Town will vote to divide the common road appropriation between the road commissioners on a mileage basis.

Article 13. To see what sum of money the Town will appropriate for State-Aid road construction (in addition to the amounts regularly raised for the care of ways, highways and bridges) under the provisions of Section 19, Chapter 28, Revised Statutes of 1930, or under the provisions of Section 3, Chapter 229 Public Laws of 1937.

Article 14. To see if the Town will vote to raise a sum of money to cut and destroy all bushes on State highways, State Aid, and third class roads, to comply with Chapter 145, Public Laws of 1937, and if so, how much.

Article 15. To see if the Town will vote to raise the sum of five hundred and thirty-seven dollars to repair and maintain third class roads, to comply with Sections 43 to 47, Chapter 28, Revised Statutes of 1930, as amended by Chapter 175, Public Laws of 1933.

Article 16. To see if the Town will vote to raise the sum of \$1,200.00 to pay bond and interest coming due this year.

Article 17. To see what sum of money the Town will vote to raise for the removal of snow.

Article 18. To see what sum of money the Town will vote for the support of the poor.

Article 19. To see what sum of money the Town will vote to raise for the contingent fund.

Article 20. To see if the Town will vote to raise a sum or money to provide for the services of a Public Health nurse, this action made legal by the Maine Legislature of 1925, Section 58, Chapter 140, Public Laws of 1925.

Article 21. To see what sum the Town will vote to pay for the collection of excise taxes.

Article 22. To see what sum the Town will vote to pay for the collection of taxes.

Article 23. To see if the Town will vote that for the purpose of procuring a temporary loan to and for the use of the Town of North Kennebunkport, to pay the indebtedness of said Town, due or to become due during the present municipal year, to be paid out of money raised by taxation during the present municipal year, the town treasurer be and is hereby authorized and directed to borrow from time to time a sum or sums not exceeding in the aggregate, ten thousand dollars, and to execute and deliver the note or notes of the town therefor, signed by the town treasurer and countersigned by the municipal officers of the Town.

Article 24. To see if the Town will vote to increase the salaries of the Selectmen to \$250.00 for chairman and \$75.00 each for the second and third members of the board.

Article 25. To see if the Town will authorize the treasurer of the Town, (with the approval of the Board of Selectmen) to

sell and dispose of all tax titles held by the Town on such terms as they deem advisable, and to execute quitclaim deeds for such property.

Article 26. To see if the Town will vote to raise the sum of \$300.00 for services of out of town fire companies.

Article 27. To see what action the Town will take with regard to transferring the money for state aid and third class highway construction, or a part of either, or both to the proposed project of rebuilding the state highway from Biddeford to Sanford. This article was requested by the State Highway Commission.

Article 28. To see if the Town will vote to instruct the Selectment to appoint a building inspector, to act under instructions as laid down in Chapter 35, Section 25-26, Revised Statutes.

Article 29. To see if the Town will vote to raise the sum of \$175.00 for the purpose of graveling sections of the Mountain Road, beginning at the top of the hill near the Day residence toward the Biddeford line.

Article 30. To see if the Town will vote to instruct the Selectmen to appoint an electrical inspector.

Article 31. To see if the Town will vote to raise the sum of \$25.00 for the purchase of fire fighting equipment, as requested by the State Forest Service.

Article 32. To act on any further business that may come before this meeting.

The Selectment hereby give notice that they will be in session at the Town Hall at nine o'clock in the forenoon on the day of said meeting, for the purpose of revising and correcting the list of voters.
